# Increasing capacities of the Ministry of Defence of Montenegro to prevent and respond to gender-based discrimination

Budva, 3-4 December 2019. Fifteen (15) members of the Ministry of Defence (MoD) and Armed Forces of Montenegro participated in the two-day seminar Gender Equality and Gender-based Violence, Sexual Violence and Violence against Women, delivered by UNDP SEESAC at the request of the MoD.

The interactive seminar made interlinkages between gender inequality and gender-based violence which is a violation of human rights and also a significant security issue. Furthermore, it increased the capacities of the MoD and AF of Montenegro representatives to identify and effectively respond to gender-based discrimination, sexual harassment and abuse.

In order to provide information on the status of gender equality in Montenegro, Mr. Sinisa Bjekovic, Deputy Protector of Human Rights and Freedoms of Montenegro, was invited to the seminar to present statistical data on the socio-economic position of women and men. The seminar also enabled the exchange of regional experiences in combating gender-based discrimination. Brigadier General Mirsad Ahmić, Inspector General in the MoD of BiH, presented the internal complaints mechanism in the AFs and shared experience in resolving gender-based discrimination in AFs of BiH.

The Strengthening of Regional Cooperation on Gender Mainstreaming in Security Sector Reform in the Western Balkans project is financed by the governments of Norway and the Slovak Republic. With the support of UNDP SEESAC, the project provides the Ministries of Defence and Armed Forces in the Western Balkans with a platform where, over the next three years, they can exchange ideas and develop policies to ensure long-term and sustainable inclusion of the gender perspective in defence policies and practices.

## Cookies on our web page

#### What is Cookie?

A cookie is a small piece of data sent from a website and stored in a user's web browse while a user is browsing a website. When the user browses the same website in the future, the data stored in the cookie can be retrieved by the website to notify the website of the user's previous activity

#### How do we use cookies?

A visit to a this page could generate the following types of cookie.

## Strictly necessary cookies

These cookies are essential in order to enable you to move around the website and use its features, such as accessing secure areas of the website. Without these cookies services you have asked for, like shopping baskets or e-billing, cannot be provided.

#### 2. Performance cookies

These cookies collect information about how visitors use a website, for instance which pages visitors go to most often, and if they get error messages from web pages. These cookies don't collect information that identifies a visitor. All information these cookies collect is aggregated and therefore anonymous. It is only used to improve how a website works.

# 3. Functionality cookies

These cookies allow the website to remember choices you make (such as your user name, language or the region you are in) and provide enhanced, more personal features. For instance, a website may be able to provide you with local weather reports or traffic news by storing in a cookie the region in which you are currently located. These cookies can also be used to remember changes you have made to text size, fonts and other parts of web pages that you can customise. They may also be used to provide services you have asked for such as watching a video or commenting on a blog. The information these cookies collect may be anonymised and they cannot track your browsing activity on other websites.

# 4. Targeting and advertising cookies

These cookies are used to deliver adverts more relevant to you and your interests They are also used to limit the number of times you see an advertisement as well as help measure the effectiveness of the advertising campaign. They are usually placed by advertising networks with the website operator's permission. They remember that you have visited a website and this information is shared with other organisations such as advertisers. Quite often targeting or advertising cookies will be linked to site functionality provided by the other organisation.
