# 12th Meeting of the Regional Arms Exports Information Exchange

As a way of strengthening safety and security through regional cooperation in South East Europe, SEESAC facilitates regular meetings of authorities responsible for the development and execution of arms transfer policies in the Western Balkan countries - the Regional Information Exchange Process (RIEP) meetings on Arms Control.



The 12th RIEP meeting took place on 25 November 2014 in

Skopje, the former Yugoslav Republic of Macedonia and participating were twenty (20) delegates from Albania, Bosnia and Herzegovina, Croatia, Montenegro, Serbia, and the former Yugoslav Republic of Macedonia. Three experts from the EU and the region were also present at the meeting, as well as representatives of UNDP's SEESAC initiative.

At RIEP meetings, participants have the opportunity to exchange relevant experiences and knowledge. Specifically, RIEP meetings aim to facilitate the process of EU alignment in the Western Balkans region, particularly with regards to arms transfers control.

The Skopje meeting was opened by Ms. Anastasija Ileska, State Secretary in the Ministry of Interior of the former Yugoslav Republic of Macedonia, and by Dr. Ivan Zveržhanovski, SEESAC Coordinator.

The session dedicated to Updates from the Region focused on the issue of building the region's capacities for reporting. The Ministry of Trade, Tourism and Telecommunications of the Republic of Serbia presented their recently upgraded software (AAERG Software), which allows for safe, detailed, and reliable recordkeeping of arms transfer licences while also offering simple and flexible options for reporting.

Kadrija Kurpejovic of the Ministry of Economy of Montenegro and Mirko Kukolj, an independent consultant, each addressed the issue of national capacities for accurate reporting to the OSCE and UN.

Mr. Kukolj and Ms. Mariann Mezey from the Hungarian Trade Licensing Office facilitated a discussion on internal compliance programmes, while Mr. Kukolj also presented the novelties in the SALW-related EU customs tariff policies and Spain's export control legislation.

# **About the Regional Information Exchange Process (RIEP)**

RIEP was initiated in 2009 as a platform for persons responsible for the development and execution of arms transfers control policies in their respective countries, to meet each other and regularly exchange relevant experiences. RIEP meetings are regularly attended by representatives of six (6) countries, namely: Albania, Bosnia and Herzegovina, Croatia, Montenegro, Serbia and the former Yugoslav Republic of Macedonia. In addition to facilitating the exchange of practices and policies among colleagues in the region, some of the important by-products of the process have been the establishment of a regional Brokering Database, as well as the jointly published Regional Reports on Arms Exports.

RIEP is a flagship activity of SEESAC's Arms Export Control project that has been generously supported by the Ministry of Foreign Affairs of the Kingdom of Norwaysince 1 January 2010. In July 2013, the Norwegian MFA decided to continue its support through the Phase II of SEESAC's Arms Export Control Programme in the Western Balkans project, which will last until June 2015.

# Cookies on our web page

#### What is Cookie?

A cookie is a small piece of data sent from a website and stored in a user's web browse while a user is browsing a website. When the user browses the same website in the future, the data stored in the cookie can be retrieved by the website to notify the website of the user's previous activity

#### How do we use cookies?

A visit to a this page could generate the following types of cookie.

#### Strictly necessary cookies

These cookies are essential in order to enable you to move around the website and use its features, such as accessing secure areas of the website. Without these cookies services you have asked for, like shopping baskets or e-billing, cannot be provided.

#### 2. Performance cookies

These cookies collect information about how visitors use a website, for instance which pages visitors go to most often, and if they get error messages from web pages. These cookies don't collect information that identifies a visitor. All information these cookies collect is aggregated and therefore anonymous. It is only used to improve how a website works.

## 3. Functionality cookies

These cookies allow the website to remember choices you make (such as your user name, language or the region you are in) and provide enhanced, more personal features. For instance, a website may be able to provide you with local weather reports or traffic news by storing in a cookie the region in which you are currently located. These cookies can also be used to remember changes you have made to text size, fonts and other parts of web pages that you can customise. They may also be used to provide services you have asked for such as watching a video or commenting on a blog. The information these cookies collect may be anonymised and they cannot track your browsing activity on other websites.

# 4. Targeting and advertising cookies

These cookies are used to deliver adverts more relevant to you and your interests They are also used to limit the number of times you see an advertisement as well as help measure the effectiveness of the advertising campaign. They are usually placed by advertising networks with the website operator's permission. They remember that you have visited a website and this information is shared with other organisations such as advertisers. Quite often targeting or advertising cookies will be linked to site functionality provided by the other organisation.
