The Association "Network of Women Police Officers" in Bosnia and Herzegovina (BiH) held its Annual Meeting

From 4-6 July 2012, the Association "Network of Women Police Officers" in Bosnia and Herzegovina (BiH), held both its Annual Meeting and a workshop on "Gender Equality in Security Sector" in Sarajevo. Events were co-organized by the Federal Police Administration, UNDP Bosnia and Herzegovina, and UNDP/SEESAC and with the support of the Gender Equality Agency in BiH.

The Association brings together women police officers from fifteen police institutions, from across the country, in an effort to raise awareness about gender equality in police services and to advocate for gender sensitive police practices. The work of the Association is supported by the UNDP/SEESAC as part of the Support for Gender Mainstreaming in Policing Practice in South East Europe project.

The goals of the Association are directly aligned with the implementation of the UNSC Resolution 1325 Action Plan in BiH calling for the increased representation of women at all decision-making levels in the national, regional, and international institutions and mechanisms for the prevention, management, and resolution of conflict.

At the annual meeting, members of Association discussed priorities and devised a plan of activities for the upcoming period. It was agreed that the promotion of the Association and development of the capacity of its members to advocate for gender equality in policing practice, should at this time take priority.

"Gender Equality in Security Sector" Workshop

In addition, on 5 and 6 July, a workshop dealing with gender based violence was organized for members of the Association. The workshop addressed gender roles and stereotypes, the international commitments and its transposition into the national legislative system, mechanisms for gender equality and protection of women in BiH, as well as dynamics of the gender based violence. One of the sessions of the workshop was specifically dedicated to sharing experiences with the Association of Women Judges in BiH, a similar association of women professionals.

UNDP/SEESAC Project Manager and Coordinator of the Women Police Officers Network in Southeast Europe (WPON), **Ms. Bojana Balon**, acquainted the workshop participants with the results and activities of WPON as a mechanism for gender equality promotion.

Participants were greeted by **Ms. Samra Filipovic-Hadziabdic**, Head of the Gender Equality Agency of Bosnia and Herzegovina; **Mr. Edin Vranj** from the Federal Police Administration in BiH, **Ms. Ankica Tomic**, the Head of the Department of International Cooperation at the Ministry of Security BiH, **Ms. Amna Berbic** from UNDP BiH, and **Ms. Marina Zovic**, the Chair of the "Network of Women Police Officers" in BiH.

What is Cookie?

A cookie is a small piece of data sent from a website and stored in a user's web browse while a user is browsing a website. When the user browses the same website in the future, the data stored in the cookie can be retrieved by the website to notify the website of the user's previous activity

How do we use cookies?

Strictly necessary cookies

These cookies are essential in order to enable you to move around the website and use its features, such as accessing secure areas of the website. Without these cookies services you have asked for, like shopping baskets or e-billing, cannot be provided.

2. Performance cookies

These cookies collect information about how visitors use a website, for instance which pages visitors go to most often, and if they get error messages from web pages. These cookies don't collect information that identifies a visitor. All information these cookies collect is aggregated and therefore anonymous. It is only used to improve how a website works.

3. Functionality cookies

These cookies allow the website to remember choices you make (such as your user name, language or the region you are in) and provide enhanced, more personal features. For instance, a website may be able to provide you with local weather reports or traffic news by storing in a cookie the

region in which you are currently located. These cookies can also be used to remember changes you have made to text size, fonts and other parts of web pages that you can customise. They may also be used to provide services you have asked for such as watching a video or commenting on a blog. The information these cookies collect may be anonymised and they cannot track your browsing activity on other websites.

4. Targeting and advertising cookies

These cookies are used to deliver adverts more relevant to you and your interests They are also used to limit the number of times you see an advertisement as well as help measure the effectiveness of the advertising campaign. They are usually placed by advertising networks with the website operator's permission. They remember that you have visited a website and this information is shared with other organisations such as advertisers. Quite often targeting or advertising cookies will be linked to site functionality provided by the other organisation.
