# Criminal Justice Response Against Arms Trafficking

The project under implementation by UNODC's Global Firearms Programme is supporting the six Western Balkans jurisdictions to strengthen their criminal justice response to firearms-related criminality, particularly illicit arms trafficking, by facilitating the harmonization of the national firearms legislation and relevant criminal and procedural law provisions with the UN Firearms Protocol. The project also works with the Western Balkans authorities in strengthening their capacities to detect, investigate and prosecute firearms trafficking and its links to other serious crimes, through improved guidelines and standard operating procedures, specialized training, information exchange, and regional cooperation.



UNODC's Global Firearms Programme provides support in four of its mandate areas: (i) legislative assistance to apply the United Nations Convention against Transnational Organized Crime and the Protocols Thereto (UNTOC) and its Protocol against the Illicit Manufacturing of and Trafficking in Firearms, their Parts and Components and Ammunition (Firearms Protocol), with a focus on the criminal and criminal procedural law provisions; (ii) support for enhancing the knowledge and skills of law enforcement and prosecutors to detect, investigate and prosecute firearms trafficking cases; (iii) support for collection and analysis of criminal justice data; and (iv) facilitation of international cooperation between criminal justice practitioners.

The project contributes to Roadmap Goals 1, 2, 3 and key performance indicators 1, 3, 8, 9, 10 of the Roadmap for a sustainable solution to the illegal possession, misuse and trafficking of Small Arms and Light Weapons and their ammunition in the Western Balkans.

Budget: US\$1,899,999

Implementing period: February 2020 - December 2021

### Results achieved as of 31 March 2021:

- Gaps identified between the criminal codes in Albania, Bosnia and Herzegovina, Serbia, and Kosovo and the UN Firearm Protocol, providing policymakers and legal experts in each jurisdiction with knowledge on how to harmonize the provisions linked to firearms trafficking with the requirements established under the UN Firearms Protocol.
- Development of draft criminal provisions in line with the UN Firearms Protocol supported in Albania, and North Macedonia
- 70 criminal justice practitioners from the Western Balkans increased their knowledge about available procedures for electronic evidence collection across borders and how to lead an effective investigation and gather admissible e-evidence from service providers.
- Draft case law collections on firearm-related offences developed in Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, and Serbia, serving as a tool for reviewing and harmonizing the court practice.

# Support for Increased International Cooperation in Criminal Matters

The project, to be implemented by UNODC's Global Firearms Programme in partnership with INTERPOL, aims to provide support to the Western Balkans jurisdictions to collect and analyze criminal justice data and facilitate and strengthen the cooperation and information exchange between criminal justice practitioners, and support detection of illicit firearms trafficking. The assistance by both organizations will result in the Western Balkans jurisdictions achieve measurable results in the implementation of the Roadmap, including the connection of all police services to INTERPOL's Illicit Arms Records, Tracing Management System (iARMS), information exchange with countries located



along connected routes and understanding of the gaps in the detection of firearms in postal shipments.

# Cookies on our web page

# What is Cookie?

A cookie is a small piece of data sent from a website and stored in a user's web browse while a user is browsing a website. When the user browses the same website in the future, the data stored in the cookie can be retrieved by the website to notify the website of the user's previous activity

#### How do we use cookies?

A visit to a this page could generate the following types of cookie.

### Strictly necessary cookies

These cookies are essential in order to enable you to move around the website and use its features, such as accessing secure areas of the website. Without these cookies services you have asked for, like shopping baskets or e-billing, cannot be provided.

#### 2. Performance cookies

These cookies collect information about how visitors use a website, for instance which pages visitors go to most often, and if they get error messages from web pages. These cookies don't collect information that identifies a visitor. All information these cookies collect is aggregated and therefore anonymous. It is only used to improve how a website works.

# 3. Functionality cookies

These cookies allow the website to remember choices you make (such as your user name, language or the region you are in) and provide enhanced, more personal features. For instance, a website may be able to provide you with local weather reports or traffic news by storing in a cookie the region in which you are currently located. These cookies can also be used to remember changes you have made to text size, fonts and other parts of web pages that you can customise. They may also be used to provide services you have asked for such as watching a video or commenting on a blog. The information these cookies collect may be anonymised and they cannot track your browsing activity on other websites.

# 4. Targeting and advertising cookies

These cookies are used to deliver adverts more relevant to you and your interests They are also used to limit the number of times you see an advertisement as well as help measure the effectiveness of the advertising campaign. They are usually placed by advertising networks with the website operator's permission. They remember that you have visited a website and this information is shared with other organisations such as advertisers. Quite often targeting or advertising cookies will be linked to site functionality provided by the other organisation.
