 An automated information system for registration of numbered weapons, parts of the numbered weapons, ammunition and their owners are the integral parts of the unified information system of the Ministry of Internal Affairs of Ukraine.

- ensuring transparency of licensing and registration activities


Implementation of modern technology of licensing and registration activities







Features of the current system

The prospects for the implementation of the registry

Employees of NPU	Registrars Employees of the NPU, Service centers of the Ministry of Internal Affairs, Certification agencies, Business entities
Responsibility Is the state authority	personal – each Registrar
