## National Commission for Small Arms and Light Weapons in Republic of Macedonia

- National strategy and Action Plan adopted by the Government of the Republic of Macedonia in 2005 year;
- The efforts of the government of Republic of Macedonia is to prevent, control and eradicate the proliferation of illicit weapons in accordance with the regional and international initiatives, standards and documents on control over weapons, ammunition and explosive materials.



## National Commission for Small Arms and Light Weapons in Republic of Macedonia

- Government of the Republic of Macedonia established the National Commission for Small Arms and Light Weapons in Republic of Macedonia in 2007 year;
- Structure of the National Commission for Small Arms and Light Weapons in Republic of Macedonia:
  - President State Secretary in the Ministry of interior,
  - National Focal Point from the Ministry of interior,
- Secretary and members from different ministries: Ministry of interior, Ministry of defense, Ministry of justice, Ministry of foreign affairs, Ministry of economy, Ministry of local government, Ministry of education and science, Ministry of agriculture, forestry and water economy and Ministry of finance Customs administration.
- The following should be represented as observers, if they are not already de facto members:
- Non Governmental Organization (NGO) representative;
- Civil Society Organization (CSO) representative; and
- other international organisations directly implementing a SALW intervention project.



### Aim and objectives of the National SALW Commission



 Aim: To secure a safer environment and control small arms and light weapons within society in order to promote the conditions for improvement of the general security in the country.

#### Objectives:

- ensure general safety and personal security of the citizens;
- reduction of the number of weapon and ammunition accidents;
- reduction of the number of weapons available to criminals;
- control of legal weapons through national legislation and registration;
- need to make a public connection between the availability of weapons and violence in the society, (by both national authorities and the civilian population at large);
- requirement to build community awareness of the problem and hence community solidarity;
- reduction and disruption of the transfer and illicit trade of weapons on the black market;
- reduction of the open visibility of weapons in the community, and change the culture of weapons;
- alteration of legal regulations in order to prevent and sanction the illegal weapons possession; and
- use of specific SALW control interventions as a launch framework for future capacity building and sustainable development.



### Role and tasks of the National SALW Commission



- The primary role of the national SALW commission is overview and control of: The planning, coordination, direction and monitoring of all appropriate SALW control interventions at the national level in order to secure a safer environment and control small arms and light weapons within society thereby creating the conditions for improvement of the general security in the country.
- The tasks of a national SALW commission is to :
- identify, determine and (if possible) quantification of the impact of SALW on society, human security and safety, and economic and social development of the country;
- Determine the priorities of a SALW control intervention and the implementation of a NAP;
- Derive and develop the operational objectives of a SALW control intervention from the aim;
- Develop and disseminate a "national SALW action plan";
- Ensure the availability of, and the mobilisation where necessary, sufficient resources to carry out the national SALW action plan;
- Approve detailed SALW intervention proposals of all appropriate stakeholders, including legislative issues, in support of the national SALW action plan;



#### Tasks of the National SALW Commission



- Disseminate timely information to all appropriate stakeholders in support of the national SALW action plan;
- Monitor all SALW intervention components in support of the national SALW action plan;
- Evaluate all SALW intervention components in support of the national SALW action plan;
- Update the national SALW action plan when appropriate to respond to changing operational situations;
- Report national SALW intervention measures to the UN Office for Disarmament Affairs (UNODA) in accordance with the UN SALW Plan of Action;
- Report national SALW intervention measures to the OSCE in accordance with the OSCE Document on SALW;
- Ensure that the UN Protocol against the Illicit Manufacturing and Trafficking of SALW,
  OSCE document on weapons, and OSCE document on stockpiles of conventional
  ammunition and any UN sanctions are complied with, for the export of SALW.
- Initiate signing of the UN Protocol against the Illicit Manufacturing and Trafficking of weapons, weapons parts, components and ammunition as a complement to the UN Convention against trans-national organized crime.

#### SALW control



 SALW control is a complex process, in which there are many components, all of which must interact correctly with each other. (The following matrix is the basis for operational SALW control interventions, which should be further developed into the National Action Plan as progress is made). The action points in the following matrix are shown against functional areas, and are in neither date or priority order. The National Action Plan will be continually updated to reflect the progress of the various component parts contained within it.

- Implementation of the ratified Arms Trade Treaty and
- Activities related to preparation of the Republic of Macedonia for membership at the Wassenaar Arrangement
