Priorities of National Commission for SALW in Republic of Macedonia

- 1. Harmonization of the domestic legislation in direction to transposition the EU legislation.
- Practical implementation of new amendments of Law of weapon and Law on production and trade of arms and military equipment;
- Create conditions to implement article 4 of Directive 51/2008 of the European Parliament and of the Council amending Council Directive 91/477/EEC on control of acquisition and possession of weapons); "Member states shall, by 31 December 2014, ensure the establishment and maintenance of a computerized data-filing system, either a centralised system or a decentralised system which guarantee to authorised authorities access to the data-filing systems in which each firearms subject to this Directive shall be recorded. This filing system shall record and maintain for not less than 20 years each firearm's type, make, model, calibre and serial number as well as the names and addresses of the supplier and the person acquiring and possessing the firearm."

National priorities



 Undertaking measures and activities for practical implementation of the legal acts and the by-laws which covers upgrading of the existing software for keeping evidence of the weapons licenses of legal and natural entities, as well as a software for keeping evidence of the licenses for import-export and transit of small arms and light weapons in/from and across the territory of the Republic of Macedonia



National priorities

 Raising awareness of the citizens for the perils of using of small and light weapons aimed at strengthening of the need to build up consciousness within the communities related to this issue and the necessity of their solidarity, as well as the need of decreased manifestation of weapons in the community and changing of the "culture for weapons". At the same there is a necessity of raising awareness of the states authorities and the population for the international correlation of availability of weapons and violence in the society.



National priorities



- Destruction of found, seized and confiscated weapons taken from the Basic Courts on the territory of the RM for which the criminal and misdemeanour procedures have been completed with final court judgments;
- Started from 2005 year, every year on 09-th of July, melt found, seized and confiscated weapons;
- This year were melt 242 pieces of weapons which were found, seized and confiscated and taken from the Basic Courts on the territory of the RM and 578 pieces of weapons which were result of stockpile reduction in Ministry of interior

Activities and National Projects



- Upgrade of the existing software for evidence of weapons license
- Developing of the component "B" of this software
- Electronically connectivity of the trade company with the Ministry of interior. In this way MOI can be able to check "on line" all weapons, their parts and ammunition which are stored in their magazines and storages.
- Besides this, the legal entities, or the trade companies would put an obligation for keeping a registry for monitoring of production (manufacture), repair and the transport of the weapons. The registry contains inscriptions of all the abovementioned data.





Activities and National Projects

- Improvement of the physical security at warehouse "Orman";
- Building a fence around the warehouse;
- Putting security video-supervision around the warehouse;
- Setting of illumination in the whole warehouse.
