**THE DEFINITION OF FARES FOR LEGAL DOCUMENTS ISSUED BY THE STATE EXPORT CONTROL AUTHORITY (AKSHE) TO SUBJECTS INVOLVED IN INTERNATIONAL TRANSFERS OF MILITARY GOODS AND DUAL-USE GOODS AND TECHNOLOGIES.**

Based on paragraph 2, of article 100 of the Constitution and article 38 of the Law No. 9707, date 05.04.2007 "On State Control of Import-Export of Military Goods and Dual-Use Goods and Technologies", on the proposal of the Minister of Defense, the Council of Ministers,

**DECIDED:**

1. The definition of fares for legal documents to subjects involved in international transfers of military goods and dual-use goods and technologies, according to Appendix no. 1, attached to this decision.
2. The definition of fares for legal documents to subjects involved in international transfers of military goods and dual-use goods and technologies, according to Appendix no. 2, attached to this decision.
3. The Ministry of Defense and the State Export Control Authority are charged with the application of this decision.

This decision enters into force after its publication in the Official Gazette.
