RULES OF PROCEDURE AMENDING THE RULES OF PROCEDURE ON THE TRAINING PROGRAMME FOR PROPER USE, STORAGE AND MAINTENANCE OF WEAPONS, THE CONDUCT OF PRACTICAL TRAINING IN HANDLING WEAPONS, AS WELL AS THE CONDUCT OF THE LICENCE EXAM IN TECHNICAL KNOWLEDGE ABOUT THE PROPER USE OF WEAPONS AND FAMILIARITY WITH WEAPON REGULATIONS

Article 1

In the Rules of Procedure amending the Rules of Procedure on the training programme for proper use, storage and maintenance of weapons, the conduct of practical training in handling weapons, as well as the conduct of the licence exam in technical knowledge about the proper use of weapons and familiarity with weapons regulations ("Official Gazette of the Republic of Macedonia" No. 83/05 and 135/08), Appendix 4 shall be replaced with new Appendix 4 enclosed herewith and constituting an integral part hereof.

Article 2

These Rules of Procedure shall enter into force on the date following the date of publication in the "Official Gazette of the Republic of Macedonia".
